



2018/2019 Competitive Player Financial Agreement

Each player will be required to pay the following fees to participate in Midwest City Soccer Club's Competitive program. These fees cover a multitude of expenses which include, but are not limited to: coaching salaries, referee fees, player/club insurance, OSA/USYSA fees, and club maintenance.

The **registration fee** will be charged through gotsoccer at time of registration and covers fall/spring seasons.

The **field usage and trainer fee** can be paid by one of three options.

- 1- One time payment of \$700 paid by August 1st, 2017. Register in gotsoccer with autopay and invoices will be voided when payment is made.
- 2- Two payments of \$350. First payment by August 1st, 2017. Second Payment by January 1st, 2017. Must register online in Gotsoccer with autopay by credit card. Invoices will be voided when payment is made.
- 3- Monthly payments- Must register online in Gotsoccer with autopay by Credit Card.
10 monthly payments on the first of each month as follows: Aug- \$110; Sept- \$60; Oct- \$60; Nov- \$60; Dec- \$60; Jan- \$110; Feb- \$60; Mar- \$60; Apr- \$60; May- \$60.
Field usage is paid in 2 payments of \$50. Payments are added to autopay for August and January.

Failure to make monthly payments reduces your coach's monthly salary accordingly. If you don't pay the club, the club can't pay the coach.

Uniforms are purchased through the club to Gregory's Sporting Goods. Basic uniform approx \$96.

Teams may play **Indoor/Futsal** during winter sessions. Payment will be made to team manager.

Each team will play 2-4 **tournaments** per year. Payments of tournaments will be made to the team manager. Tournament payments may include hotel, gas and meal per-diem for coach. **ALL** rostered players are responsible to pay their part, whether they attend or not.

Once a player is registered as a competitive player, the player and parent are committing to the fall & spring seasons (Aug-May) and to all associated fees. Any delinquency in fees associated with the competitive program, due their team, or the MWCSO may result in the player or family being placed in "Bad Standing" within MWCSO and/or OSA. Any player that is placed in bad standing CANNOT play for any other OSA team until full payment is made to MWCSO.

By signing below, I understand all items contained in this competitive financial agreement and that I am contractually bound to pay all fees associated with the competitive program as they apply to my player.

If autopay payment has not cleared by the 10th of the month, the player will not be able to attend practices or games until all fees are paid. If no payment is made by the end of the month, the player will be placed in bad standing and removed from the team roster. Per Oklahoma statutes, Title 21 sections 1541.1-1541.4, the club may pursue criminal charges and payments through the Oklahoma County District Attorney. A \$25.00 NSF fee will be added for any payment that is denied due to insufficient funds.
